Dear University Senate Members:

Honestly, I am both shocked and humbled to be nominated for this year's Student Outreach Award. However, I am extremely appreciative of the unnamed University Senate member(s) who felt my contribution to supporting students worthy of nomination.

I have worked in higher education for almost three decades. Over the last nine and a half years, I have worked in the Division of Student Affairs. Currently, I serve as the Director of Student Conduct and Academic Integrity.

My department, Student Conduct and Academic Integrity, is responsible for ensuring a fair, just and impartial restorative justice process for students and organizations accused of violating the Code of Conduct or Honor Code, with a goal of educating and providing resources to achieve respect, civility and integrity for all members and stakeholders of the University community.

The aforementioned mission keeps me grounded and focused on meeting the needs of students. When I took the role of director, I brought the practice of restorative justice to Conduct at Tech. The focus on restorative justice is central to how I deal with students. My approach to aiding students in what I sometimes refer to as "Conduct Crisis" is fairly simple: 1) I advocate for them using honesty and transparency; 2) I afford them dignity by not kicking them while they are down; 3) I allow them latitude to express their sometimes raw emotions; 4) I provide them with opportunities to self-reflect and take ownership; 5) I challenge them to learn from their current situation; and 6) I hold them accountable.

Many students, who have previously gone through the Conduct process, some with less than favorable outcomes, have sought me out in pursuit of guidance on both Conduct and non-Conduct matters. A significant number of these students over the years have become my mentees. I think this phenomenon springs from the fact that these students felt they were treated fairly and were heard, and they perceived someone exemplified care for their overall wellbeing.

I see myself as genuinely student-centered, and I am most proud that students see this. As a result, I take both personal and professional satisfaction in providing quality service to students. Thank you for nominating me as a candidate for this year's Student Outreach Award.
