Dear Committee:

First, let me say I am very honored and surprised to be nominated for the 2021-2022 Outstanding Service Award for classified staff. I do love my job and helping others perform well at theirs.

I have been married to my wonderful husband for almost 19 years now. We have two boys, ages 17 and 27. My youngest plans to attend Tech in late 2023.

I began working at Louisiana Tech in my current position in July of 2012 (Electrical Engr., Computer Science, Cyber Engr., & Cyber Security Engr. Technology). I currently coordinate with three Program Chairs, serve 31 faculty and over 800 students, as well as many other faculty and staff within the College of Engineering and Science. My responsibilities also include supervising student workers and performing administrative tasks such as processing university forms (now on Workday), prepare travel arrangements, reimbursements, quarterly course audits, textbook adoptions, help prepare for ABET, coordinate with alumni through our three programs' Advisory Boards, as well as clean/make ready offices for new faculty. Over the years, my duties expanded significantly, most notably when I inherited the duties of our building's System Analyst when he left in 2014 and that position was eliminated. Some of those duties include handling my building's Inventory as Property Custodian, managing building and room entry, changing door locks, physically moving equipment and furniture, and basic building maintenance/repair, including ongoing water-penetration issues on rainy days. For instance, I personally researched why our building kept leaking from heavy rains on the first floor, and was able to lead efforts to improve this by about 95%. In addition, in 2018 I joined the COES Safety Team, attending monthly meetings, and coordinating safety policies for Nethken Hall consistent with the needs of the college.

Over my 10 years, I have trained or help to train five other Administrative Assistants in other departments within the college. Several still reach out to me since I am one of very few who has been in this position as long as I have. I know there are opportunities for promotions all the time, but I truly love where I am and the people I work with.

Dear Colleagues,

I am writing in support for Mrs. Marsha Smith and her nomination for the Louisiana Tech Service Award recognized through the Louisiana Tech Senate. As an Academic Director in the College of Engineering and Science and a professor in the Mathematics and Statistics Program, I have had the pleasure of knowing Marsha for the past seven years. In this time Marsha has repeatedly demonstrated her passion in supporting the academic enterprise through her many years of service to our faculty, students, staff on campus as well as many external stakeholders for the college and university. Marsha has a solid work-ethic which I believe is at the core of her desire to see that everyone she serves has every opportunity to succeed.

I have worked directly with Marsha in serving the Computer Science, Cyber Engineering, Electrical Engineering, Electrical Engineering Technology as well as Mathematics & Statistics faculty and students in the College of Engineering and Science. Administrative Assistants in the College fulfill many day-to-day functions to ensure that faculty have what they need to be successful. As the Academic Director for multiple programs in the college, I relied on her servant-leadership every day. She has been in a key role for Computer Science during a time of unprecedented growth in student population (Computer Science is now the 3rd largest major, by student population, in the university). As a result, the demands required to meet the needs of faculty who serve our students has increased four-fold. Complexities have emerged which continue to require creative solutions, and Marsha does not shy away from these. For many years now, Marsha and I have discussed our mutual desire to create environments where faculty can help students succeed. Recognizing early that Marsha's responsibilities were well beyond the typical administrative assistant in the college, she immediately became core to problemsolving what I call 'environment issues' – issues that can too easily distract students from learning and faculty from being able to teach.

One of her responsibilities was due to an administrative change when the building manager moved to a different position on campus. At that point, over seven years ago, Marsha became the Building Custodian. Practically, this means that whenever there is an issue or question with the building, she is the one who facilitates discussion and coordinates changes. For example, when faculty have technology issues, she handles any work-orders, to be sure, but she is proactive in finding longer-term solutions to problems. When students or faculty have questions about using space in the building, she starts the process to determine the viability and then takes action. As I mentioned, she takes a proactive approach to preparing the best environment possible for faculty, from coming up on the weekends to clean-out and organize space to cleaning, yes physically cleaning, an office before a new faculty arrives on campus.

Her proactive approach has been noticed by others across campus. Most recently, Jim Palmer expressed his thankfulness for her service beyond what he routinely would expect. He wrote:

"In the past couple of years, she [Marsha] has been one of (if not the) first persons done with inventory in our College. She does this herself without grad assistants or student workers. . . the rate and professionalism that she accomplishes this task is impressive. Because she jumps on this task so quickly, she is often the one that helps me identify and fix any issues that might be occurring that year (which helps everyone else). She's been a great asset on this, is a self-starter, and requires no oversight from me to complete her tasks (it is a pleasure to work with her)."

To this same end, I have known her to arrange for trailers and trucks to be available for moving larger items to the South Campus 'Property' and then working with student-workers to physically move items to-and-from Nethken Hall (working right along-side her students).

To illustrate her servant-heart further, Nethken Hall had serious water-penetration issues during storms from before I moved to the building (prior to 2014). Almost every time it rained, water would be in the main hallways and in numerous classrooms. She was the one who was mopping the floors and attempting to take care of the facility each time. When a storm would come through over a weekend, she would come by and check on the water issues. All of this would go completely unnoticed to others on campus, yet she was guaranteeing the safety of the building each time – especially since Nethken houses the Power Lab – where Electrical Engineering students learn how high voltage works through laboratory experiences. Her calm efforts to guaranteeing a safe working environment is a testament to her service to the university. Of course, I should mention that her problem-solving didn't stop there. While I complained to upper-administration about the water issues with the building, requesting as assessment from our own facilities personnel - even having additional engineers to look at why the leaks were occurring - Marsha eventually found the main problem with the building. Discovering that the 'weep holes' where the brick wall meets the foundation could be blocked by simple debris that would typically occur over time, she and her student-workers 'drilled out' the debris in every 'weep hole' around the entire building, and the water penetration during storms almost ceased. Since she initiated these steps, the building has had fewer issues with water. Of course, from her point of view this all happened as part of her 'regular' responsibilities, because Marsha sees her position at Tech as part of her life and not just a job. If we wanted to, we could easily give accounts of many - students, faculty and alumni who have been impacted by the efforts of Marsha Smith - many who have positive memories of our college because Marsha will go the extra mile every time. This award will recognize and give honor to her active engagement in meeting the needs of students and faculty.

Marsha's quiet approach to helping others achieve is something that she would not want anyone to recognize publically. However, this is long-overdue. Through her solutions to real problems and challenges that impact our faculty and students, I have observed her passion for meeting needs and challenges in the lives of others. I have been able to observe this activity both within our programs and within the college and university. By being present at numerous events, students recognize a familiar face and can engage in conversation outside of the work-environment. Whether it is serving at Gumbo Fest, helping at Spring Release, or one of our numerous athletic events, Marsha's presence goes a long way to showing students how much she admires their efforts and the university as a whole. Through her numerous activities, she has established a network of close colleagues across campus through which she is able to serve others.

I believe that Marsha is one of the most service-oriented members of the university community. From solving problems for students, to answering questions of faculty; from building relationships with other staff members to going the extra mile with students whose lives are falling apart; Marsha demonstrates every day how much she cares about Louisiana Tech and all that it represents. She is realistic yet visionary – serving others beyond what anyone would expect and garnering trust for the college and university at a time when we have most needed it.

Please consider that Marsha has my highest recommendation, and I will be glad to answer any questions directly should you consider that necessary.
