Unaccompanied - means you are NOT living with in the physical custody of your parent or guardian. Youth - means you are under 21 years of age or younger or are still enrolled in high school as of the day you sign your FAFSA.

	ATTACH Documentation Verifying Homelessness or Risk of Homelessness Attach documentation from one of the following: <ul style="list-style-type: none">- A School District Homeless Liaison- A director or designee of a HUD-funder shelter- A director or designee of another homeless shelter The documentation must confirm: <ul style="list-style-type: none">- You are an unaccompanied homeless youth - Effective after July 1, 2024, you are living in a homeless situation as defined by the school district homeless liaison and you are not in the physical custody of a parent or guardian.- You are an unaccompanied, self-supporting youth at risk of homelessness - Effective after July 1, 2024, you are not in the physical custody of a parent/guardian, you provide for your own living expenses entirely, and you are at risk of losing your housing.
